## CDBG Covid-19 Rental Assistance Program

- CDBG Program:
  - What is the CDBG Covid-19 Rental Assistance Program?





#### **Eligibility Requirements**

- Minimum Requirements:
  - Have COVID-related financial hardship
  - Households must have a delinquent rent balance
  - Household gross income is at or below the following:
    - 1 Person household \$63,000
    - 2 Person household \$72,000
    - 3 Person household \$81,000
    - 4 Person household \$90,000
    - 5 Person household \$97,200



## **Eligibility Requirements (cont.)**

- Households must have experienced a financial hardship due to or related to COVID-19
  - Hours reduced
  - Job loss, furlough, lay-off
  - Unable to work due to school or daycare closing
  - Lost income due to caring for a family member with COVID-19
- Households that are behind on their rent obligations
  - Qualified household is eligible for a maximum benefit amount of six (6) months of rent ONLY, excluding utilities and fees (late, parking, pet, etc.)



#### **Application Requirements**

- CDBG Rental Application (all members 18 and older must sign the application)
- Conflict of Interest Disclosure Form (all members 18 and older must sign the disclosure form)
- If customers have recertified between January 2022 February 2023, additional documentation may not be required
- If customers have NOT recertified between **January 2022 February 2023**, only one of the following documents may be required: Paystubs, Tax Return OR Bank Statements



#### **Self-Certification Affidavit**

- The customer can complete the self-certification affidavit in the event they have exhausted all efforts to obtain documentation to support a COVID-related hardship, such as:
  - Furlough/Layoff letter
  - Closure of daycare center
  - Pay Stubs
- The customer must provide a detailed description of the COVID Impact including the dates of the hardship and why they are unable to provide the supporting documents



#### **Frequently Asked Questions**

- I received COVID related rental assistance from another program, am I eligible for assistance from CDBG?
  - Yes, even if you already received COVID Rent Relief Program funds from another program, you are eligible to apply for additional funds from the CDBG Program
- Will you file in court for non-payment of rent if I have an application pending?
  - No, HOC will not file in court for non-payment during this process.




#### **Final Notes**

- Customers must submit the application and supporting documents no later than June 1, 2023
- Completed applications along with supporting documents can be emailed to cdbg\_rap@hocmc.org

• Staff will render a decision within 30-days from the time that HOC has received all documents

Award of funds will go directly to your property manager to apply to your account



## Final Notes (cont.)

- Reasons why an application would be denied:
  - Household did not experience a COVID related financial hardship
  - Household gross income exceeds the income limit

## **Housing Stabilization Program**

The Housing Stabilization Program is an emergency services program that provides financial assistance for rent arrearages, utility arrearages, security deposits, moving expenses, and storage fees. You must have a documented emergency to be eligible. For rental assistance you must have an eviction notice from the court. For utility assistance you must have a shut off notice.

#### **Fatherhood Initiative**


